

Closed-end funds (CEFs) continued their strong 2021 performance with a solid Q2. The Morningstar All Municipal CEFs Peer Group Index¹ returned 3.30% and 6.30% for the quarter on net asset value (NAV) and market price, respectively. RMI (the “Fund”) returned 4.46% and 6.68% on NAV and market price, respectively, compared to the Bloomberg Barclays US Municipal Bond Index total return of 1.42%.

The average discount of the Fund’s CEF portfolio is 3.18%, which represented a discount narrowing of approximately 2.7 percentage points quarter over quarter. We continue to believe that demand for municipals, along with low borrowing costs and low institutional ownership (creating a potential reduction in selling pressure) could drive discounts even narrower.

The Fund’s yield, duration, and asset allocation were, broadly speaking, relatively unchanged over the quarter.

Notes from MacKay Municipal Managers

AAA benchmark municipal yields moved lower during the quarter and the yield curve flattened. However, municipal-to-Treasury ratios remained stable and valuations remain relatively rich while market technicals remain supportive. The high yield segment of the market outperformed investment grade as flows remained strong into high yield mutual funds and investors sought out incremental spread. Given this backdrop, the fund’s credit selection and overweight exposure to the Leasing and Local Government Obligation sectors drove performance. Consequently, the fund’s underweight exposure to beta, particularly high grade credits and the State GO sector, represented a modest drag on relative performance. The U.S. Treasury futures hedge was the most significant drag on relative results.

Definitions:

A closed-end fund is a portfolio of pooled assets that raises a fixed amount of capital through an initial public offering (IPO) and then lists shares for trade on a stock exchange.

Yield refers to the earnings generated and realized on an investment over a particular period of time.

Duration is a measure of the sensitivity of the price of a bond or other debt instrument to a change in interest rates. Duration is non-linear and accelerates as time to maturity lessens.

Basis Point (bps) is a common unit of measure for interest rates and other percentages in finance. One basis point is equal to 1/100th of 1%, or 0.01% (0.0001), and is used to denote the percentage change in a financial instrument.

Beta reflects the sensitivity of a fund's return to fluctuations in the market index. A beta of 0.5 reflects half of the market's volatility as represented by the Fund's primary benchmark, while a beta of 2.0 reflects twice the volatility.

Credit spread is the difference in yield between a U.S. Treasury bond and another debt security of the same maturity but different credit quality.

Credit ratings are measured on a scale that generally ranges from AAA (highest) to D (lowest). All fund securities except for those labeled "Not Rated" and "Other" have been rated by Moody's, S&P or Fitch, which are each a Nationally Recognized Statistical Rating Organization ("NRSRO").

A general obligation bond (GO bond) is a municipal bond backed solely by the credit and taxing power of the issuing jurisdiction rather than the revenue from a given project.

A yield curve is a line that plots yields (interest rates) of bonds having equal credit quality but differing maturity dates. The slope of the yield curve gives an idea of future interest rate changes and economic activity.

¹The Morningstar All Municipal CEFs Peer Group Index is an equally-weighted index of all Closed-End Funds that invest substantially all of their assets in closed-end funds categorized by Morningstar as utilizing a municipal bond investment strategy. Municipal bond closed-end funds are defined as funds that invest in a diversified portfolio of investment grade municipal bonds in a variety of sectors and States.
