

Closed-end funds (CEFs) continued their strong 2021 performance with a solid Q2. The Morningstar “All CEFs” Peer Group Index returned 5.13% and 7.89% for the quarter on net asset value (NAV) and market price, respectively. RSF (the “Fund”) returned 8.06% and 13.86% on NAV and market price, respectively compared to the Bloomberg Barclays US Aggregate Bond Index total return of 1.83%.

In conjunction with the Fund’s broadened investment mandate announced in April 2020, the Fund opportunistically allocates its assets to four primary asset classes: investment company debt (ICD), CEFs (including business development companies (BDCs)), special purpose acquisition corporations (SPACs) and marketplace lending-related assets. This latter group consists of small business whole loans originated by Square Capital as well as both senior and residual asset-backed securities. The Fund also took advantage of the significant drawdown in bitcoin to take a small position in a bitcoin trust as it traded down to a discount to its NAV.

The timing of the shift in investment strategy came at an opportune time in our view and has contributed to the Fund’s recent strong performance. The Fund ranks in the top 11% of its Morningstar category for the past year based on NAV performance\*. It’s worth emphasizing that these rankings are based on NAV returns and the Fund’s total return on a market price basis has been 22.35% higher than its NAV performance over the past 12 months. The Fund now trades at the smallest discount to NAV since its listing in June 2019 ending the quarter at less than a 1% discount to NAV.

The Fund’s investment company debt exposure (debt securities issued by BDCs and CEFs that are used to lever their portfolios) is the Fund’s largest holding at 31.37%. Even though ICD yields have come in considerably since March 2020, in our view this paper offers attractive yields relative to investment-grade corporate debt with a lower probability of loss from default.

The small business portfolio (26.2% of the Fund’s holdings), which consists of merchant cash advance loans originated by Square Capital, has continued to perform well. As a reminder, these assets are repaid based on a percentage of each merchant’s daily revenue with an expected maturity of roughly 9 months, on average, at inception. As business activity has continued to increase post-lockdowns, this has been reflected in an uptick in merchant revenue and has been a positive contributor to the portfolio’s performance.

After a record run of issuance ending in February 2021, the SPAC market has recently cooled. This provides opportunity in both the primary (new issue) and secondary markets. In our view, the performance of the SPAC market in 2020 and early 2021 was an aberration and we are now back to a more normal state. We believe the asset class offers a unique and asymmetric return profile. In general, we look to purchase SPAC units at the initial public offering (IPO) price or better. The team favors units with strong sponsorship and/or what they view as attractive terms. The units we purchase are then split into common stock and warrant. With time, the common stock will be sold back to the issuer (via the tender offer) or into the secondary market, if the price is higher. The warrants may be retained after the consummation of a merger, in speculation of further upside.

The CEF portion of the Fund is essentially a diversified credit portfolio (bank loans, high yield and emerging market debt). The average discount of the Fund’s CEF portfolio is 3.05%. While CEFs have continued their exceptionally strong performance from the March 2020 lows, we believe that discounts at current levels combined with strong positive sentiment create an attractive relative value environment (relative to owning similar underlying assets in a different “wrapper,” such as an open-end mutual fund or ETF).

The Fund is a closed-end fund and closed-end funds do not continuously issue shares for sale as open-end mutual funds do. The Fund now trades in the secondary market. **Definitions:**

A Closed-End Fund is a portfolio of pooled assets that raises a fixed amount of capital through an initial public offering (IPO) and then lists shares for trade on a stock exchange.

Investment Company (ICD) are non-equity securities. Notes typically obligate issuers to repay creditor the principal loan, in addition to any interest payments, at a predetermined date.

A Business Development Company (BDC) is an organization that invests in small- and medium-sized companies as well as distressed companies. A BDC helps the small- and medium-sized firms grow in the initial stages of their development.

A Special Purpose Acquisition Company (SPAC) is a publicly traded company that raises a blind pool capital through an initial public offering (IPO) for the purpose of acquiring an existing company.

Bitcoin Trusts hold digital currency, allowing investors to trade shares through brokerage or retirement accounts, rather than cryptocurrency exchanges.

Risk-Adjusted Return – a calculation of the profit or potential profit from an investment that takes into account the degree of risk that must be accepted in order to achieve it.

Asymmetric Risk-Adjusted Return is a situation where the potential gains and losses from an investment are uneven. An asymmetrical risk reward situation can be both positive and negative. A positive one is where you can only lose an amount that is smaller than the potential reward. A negative risk reward situation is one where you can lose more than the potential positive reward.

An initial public offering (IPO) refers to the process of offering shares of a private corporation to the public in a new stock issuance.

Cash-like return refers to an asset that is so easily and quickly convertible to cash that holding it is essentially equivalent to holding cash.

Units are what public investors in SPACs receive. Each unit is comprised of one share of common stock and a fraction of a warrant to purchase a share of common stock in the future. The per unit purchase price is almost always \$10.00. Following the IPO, the units become separable, such that the public can trade units, shares, or whole warrants, with each security separately listed on a securities exchange.

Warrants are a derivative that give the right, but not the obligation, to buy or sell a security - most commonly an equity - at a certain price before expiration.
