

## Investment Objective

The RiverNorth Opportunities Fund, Inc. seeks to total return consisting of capital appreciation and current income.

## Investment Strategy

The RiverNorth Opportunities Fund, Inc. ("the Fund") employs a tactical asset allocation strategy primarily comprised of closed-end funds (CEFs), exchange-traded funds (ETFs), special purpose acquisition companies (SPACs), and business development companies (BDCs). RiverNorth implements an opportunistic investment strategy designed to capitalize on the inefficiencies in the closed-end fund space while simultaneously providing diversified exposure to several asset classes.

\*\*The Fund has implemented a level distribution policy resulting in monthly distributions of \$0.1278 per share of common stock, representing an annualized distribution rate of 13.2%. Distributions may be paid from sources of income other than ordinary income, such as net realized short-term capital gains, net realized long-term capital gains and return of capital. The Fund estimates that 59.87% of the distribution is attributable to return of capital and 40.13% is attributable to net investment income. The actual amounts and sources of the amounts for tax reporting purposes will depend upon the Fund's investment experience during the remainder of its fiscal year and may be subject to changes based on tax regulations. If a distribution includes anything other than net investment income, the Fund provides a Section 19(a) notice of the best estimate of its distribution sources at that time. These estimates may not match the final tax characterization (for the full year's distributions) contained in shareholders' 1099-DIV forms after the end of the year.
