

Investment Objective

The RiverNorth Managed Duration Municipal Income Fund, Inc. seeks to provide current income exempt from regular U.S. federal income taxes¹ with a secondary objective of total return.

Investment Strategy

The Fund's Managed Assets are allocated among two principal strategies: Tactical Municipal Closed-End Fund (CEF) Strategy (managed by RiverNorth) and Municipal Bond Income Strategy (managed by MacKay Shields LLC).

The Tactical Municipal CEF Strategy typically invests in municipal CEFs and exchange-traded funds (ETFs) seeking to derive value from the discount and premium spreads associated with CEFs. The Municipal Bond Income Strategy primarily invests in municipal debt securities of any credit quality, including securities that are rated below investment grade².

RiverNorth determines which portion of the Fund's assets is allocated to each strategy and may, from time to time, adjust the allocations. The Fund also implements a managed duration strategy which targets a weighted average effective duration within three years of the weighted average effective duration of the Bloomberg US Municipal Index (excluding the effects of leverage).

¹Managed Assets are the Fund's total assets (including any assets attributable to leverage), minus the sum of its accrued liabilities (other than Fund liabilities incurred for the purpose of creating effective leverage (i.e. TOBs) or Fund liabilities related to liquidation preference of any preferred shares issued). Managed Assets includes the effects of leverage and investments in affiliated funds.

²Leverage is based on the use of proceeds received from tender option bonds transactions (TOBs), issuing Preferred Shares, or funds borrowed from banks or other institutions, expressed as a percentage of "Managed Assets."

³The Fund has implemented a level distribution policy resulting in monthly distributions of \$0.0916 per share of common stock, representing an annualized distribution rate of 6.6% as of 9.30.24. Distributions may be paid from sources of income other than ordinary income, such as net realized short-term capital gains, net realized long-term capital gains and return of capital. The Fund estimates that 44.13% of the distribution is attributable to current year net investment income and 55.87% is attributable to return of capital. The actual amounts and sources of the amounts for tax reporting purposes will depend upon the Fund's investment experience during the remainder of its fiscal year and may be subject to changes based on tax regulations. If a distribution includes anything other than net investment income, the Fund provides a Section 19(a) notice of the best estimate of its distribution sources at that time. These estimates may not match the final tax characterization (for the full year's distributions) contained in shareholders' 1099-DIV forms after the end of the year.

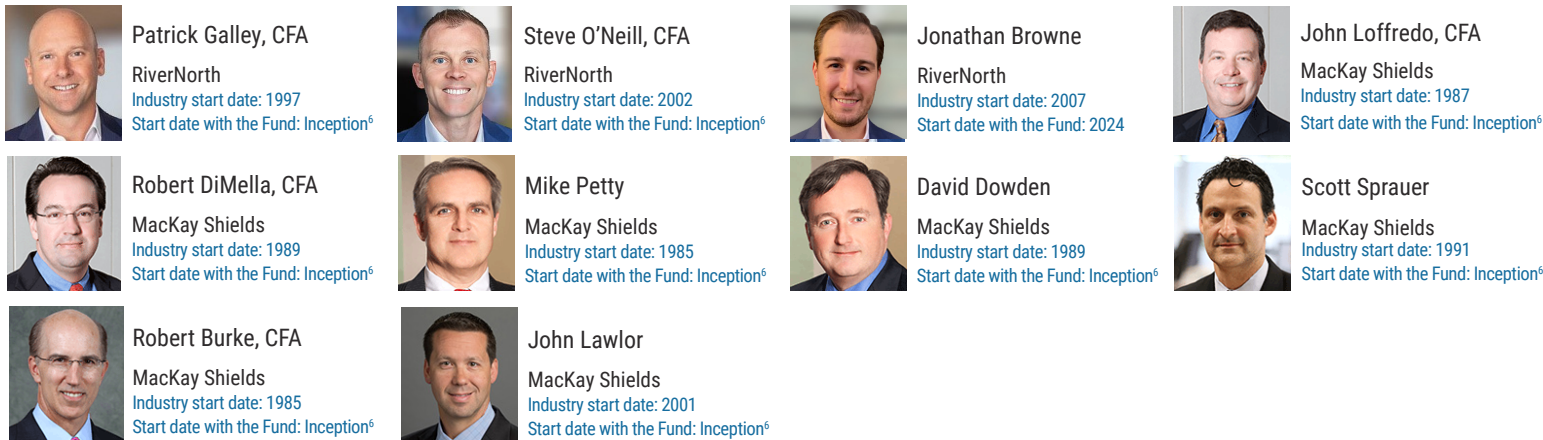
